At the hearing, any taxpayer may appear and be heard in favor of or against any proposed expenditure. After the public hearing is concluded, the Board will convene in regular session and finally determine and adopt estimates of proposed expenditures for the purposes stated in the published proposal. The adopted estimates constitute the budget of GVDWID. The agendas for both the hearing & meeting and summaries of expenses and will be posted at the GVDWID office and the US Post office in Green Valley.
